**Commissioner Zenzinger:** Commissioner Zenzinger thanked Alameda Connects for welcoming her to her first meeting with the group and expressed appreciation for their hospitality. She also attended the Arvada Chamber Awards Luncheon, where the Pioneer Award was presented to Bob West in recognition of his longstanding contributions and advocacy for Jeffco Open Space. Keith Cowling received the Man of the Year Award, and Barb Stolte received the Woman of the Year Award. Image Awards were also given to Chris Duncan, Kathy Kuehn, and Jack Emery. Commissioner Zenzinger highlighted the Rising Star Award recipient, Aaron "Junior" Aragon, a senior at Arvada High School. She spoke about how wonderful it was to meet him and how impressed she was by his fashion design project and entrepreneurial spirit. Commissioner Zenzinger also attended the Sheriff's Remembrance Ceremony for the first time and described the experience as truly beautiful. She participated in the Senior Heroes Award Celebration, an annual event sponsored by the Jefferson County Council on Aging and the Seniors' Resource Center. The event was emceed by Kerri Johnson, a longtime advocate and Director of Crime Prevention in the 1st Judicial District Attorney's Office. The celebration honored seniors in the community who have made significant contributions. Charlie and Sooze Gilbert were recognized for their work signing seniors up for emergency response lookout alerts. Stan Jacobson received an award for his service through the Seniors Resource Center, where he has been known as a "Stan of all trades." Al Blount was also recognized for his over 20 years of volunteer work at the Golden Train Museum, dedicating countless hours and contributing to special events. Bob Stjernholm was honored for his work in the IT department at Lutheran Hospital, where he played a critical role in the hospital's transition into a new facility. Cathy Loomis was acknowledged for her long-term commitment to championing community events. Jim Rose was also recognized for his work with the Apex Park and Recreation District, particularly for his involvement with the Senior Center and Project Angel Heart. Commissioner Zenzinger noted how rewarding the event was and emphasized that, although the recipients were

humble, they were clearly deserving of recognition. She continued her report with updates on the Jeffco Head Start and Jeffco Prosperity Project, both of which have been focused on the potential cuts to social safety net programs being discussed in Congress. She emphasized the power of sharing stories to illustrate the importance of these programs. The two programs came together at the request of Congresswoman Brittany Pettersen to highlight stories of mothers and families positively impacted by these services. Commissioner Zenzinger reported that cuts to the Social Services Block Grant Program now appear to be off the table, along with a scaling back of proposed cuts to the Temporary Assistance for Needy Families (TANF) program. She credited the community's storytelling efforts for this progress. However, she remains concerned about proposed changes to the Supplemental Nutrition Assistance Program (SNAP) and Medicaid and urged the community to shift their advocacy focus to these areas. Commissioner Zenzinger also attended the Head Start Parent and Community Engagement Council meeting on May 12, where these topics were discussed further. The meeting included a call to action encouraging the sharing of uplifting parent stories to emphasize the importance and value of these programs. Head Start Director Rachel Meixner shared an opportunity to sign a letter to the President and Congress, advocating for the continued support of the Head Start program. Commissioner Zenzinger requested that the link to the letter be added to the Jeffco.us website to encourage public participation in the effort.

Commissioner Kerr: Commissioner Kerr reminded the public that high school and college graduations are taking place across the State. He plans to attend Red Rocks' graduation ceremony this Saturday and extended congratulations to all graduates. He also recognized the achievements of many high school sports teams that advanced to state competitions. In boys' lacrosse, teams from Ralston Valley, Columbine, Lakewood, and Chatfield qualified for the 5A playoffs, while Green Mountain, Golden, Dakota Ridge, and Evergreen made it in the 4A bracket. He also reminded the public that the State Track Meet is being held at Jeffco Stadium and advised avoiding 6th Avenue and Kipling during that time due to increased traffic. Commissioner Kerr mentioned upcoming events he plans to attend, including the Rotary Club of Golden's Ethics in Business Awards on Friday, May 16, and the Deer Creek Canyon Park field trip with the Mile High Flood District on Thursday, May 15, which will focus on upcoming flood prevention projects. He noted that the Jefferson County Sustainability Commission will be hosting retired chief meteorologist Mike Nelson this month. Nelson will discuss the science behind weather and climate, emphasizing the importance of science despite political pressure to downplay it. Commissioner Kerr also shared his experience attending an event at the Governor's Mansion last Monday, celebrating an agreement with Union Pacific regarding the Moffat Tunnel—a vital part of the nation's rail

infrastructure. This agreement ensures the tunnel remains open for both passenger and freight traffic. He highlighted a significant increase in ski train ridership this past season and shared hopes that next year will bring a new passenger rail line running from Denver to Granby, and eventually to Craig and beyond. Last Friday, Commissioner Kerr volunteered at Jeffco Eats, where his team was praised for their efficiency—packing 250 lunches by break time and completing 500 boxes by day's end. He encouraged residents to volunteer with local organizations, especially those focused on food access, as many are currently in need of help. He concluded his remarks with a "Go Nuggets!"

Commissioner Dahlkemper: Commissioner Dahlkemper recognized that May is Wildfire Preparedness Month and emphasized the importance of community safety. She gave a shout-out to Fire Management Officer Brian Keating, who recently updated the Community Wildfire Preparedness Plan (CWPP), which outlines key strategies to increase wildfire resiliency. She also discussed the role of "healthy fire" and controlled burns in mitigation efforts and noted that the definition of the Wildland-Urban Interface has been expanded in hopes of attracting more grant funding for community support. She expressed concern about the rising cost of homeowners insurance, which was a topic during the recent legislative session. Although two of the three bills addressing the issue did not pass, efforts will continue through the Colorado Fire Commission. Commissioner Dahlkemper thanked ambassadors and community members elected to boards and commissions for their continued work in support of firefighters and public safety. She also acknowledged that May is Asian American and Pacific Islander Heritage Month and highlighted the community's artistic contributions, not just during this month but throughout the year. She shared her excitement about meeting one of her favorite authors, Juhea Kim, who is of Korean descent. Commissioner Dahlkemper also attended the Alameda Connects meeting and expressed gratitude for their partnership. She attended the Sheriff's Remembrance Ceremony and noted how moving it was to honor those who gave their lives in the line of duty. Lastly, Commissioner Dahlkemper offered her appreciation to Jansen Tidmore, CEO of the Jefferson County Economic Development Corporation, who is stepping down from his position. She thanked him for his five years of service and the significant impact he made in the community.

**County Manager:** County Manager Joe Kerby also thanked Jansen Tidmore for his contributions to Jefferson County. He encouraged the public to participate in upcoming County meetings, including the Airport Advisory Board Meeting and the Jeffco Idea Advisory Commission Meeting on May 14, as well as the Budget Advisory Committee meeting on Thursday, May 16. He concluded by inviting residents to the Virtual Town Hall scheduled for Monday, May 19, offering an

opportunity to engage directly with the Board of County Commissioners and other County leaders.

### **Background:**

Final Board action on 16 abatement petitions, \$789,416.52 to be refunded. Taxpayers have filed abatement petitions alleging that their property has been overvalued or that their tax levy is illegal. The Assessor recommends approval of these petitions in the amounts indicated in the corresponding resolutions. The Board is taking action on these abatement petitions by accepting or rejecting the Assessor's recommendations.

If an abatement appeal is approved by the Board, the Treasurer's Office will calculate interest owed and send payment to the taxpayer. The Property Tax Administrator must approve all refunds in excess of \$10,000.00. If unsatisfied with this Board's action, a taxpayer may appeal further to the State Board of Assessment Appeals. Abatement refunds over \$10,000.00 are recommended for the following reasons:

A25-003: Assessor recommends approval. Adjusted to equalize the 2024 adjusted value.

A25-031: Assessor recommends approval. Matching the 2023 stipulated value with the 2024 value.

A25-032: Assessor recommends approval. Value reduced to the 2023 Board of Assessment Appeals stipulated value based on changes to inventory.

A25-030: Assessor recommends approval. Equalized to 2024 adjusted value.

A24-448: Assessor recommends approval. Equalized to the 2024 Board of Equalization value.

A25-033: Assessor recommends approval. Equalized to the 2024 appeal.

A25-009: Assessor recommends approval. There was a decimal error inputting multi factor. Had fire damage to 4 units making them uninhabitable. Percentage good equals 56 percent.

### **Background:**

Xcel Energy gas and electric facilities are located within the right-of-way of Callender Drive, and will be impacted by the construction of Taxiway K. Airport staff have coordinated with Xcel Energy on the necessary adjustments to these electric and gas lines.

These utility adjustments require the dedication of new easements on Jefferson County property where proposed realignments are not covered by existing easements or right-of-way.

### **Background:**

HD Quincy, LLC's planned improvements included a traffic report and analysis that showed that the intersection of Quincy Avenue and Tufts Avenue would be failing during peak hour traffic. The remedy for this failure would be either a traffic signal or a roundabout. Colorado Department of Transportation (CDOT) will not allow a traffic signal because of the proximity to their newly constructed C470 ramp roundabout. The Traffic Impact Fee program had included this segment of Quincy to provide and fund the improvements.

Staff would like to pay the developer for the County's share of these improvements after the acceptance of the roadway in one lump sum. The County shall pay to HD Quincy, LCC a one-time payment in the amount of \$1,874,092. If improvements are completed and accepted in 2025, a budget supplemental will need to be submitted, or if completion and acceptance is not until 2026, the funds will be budgeted in 2026.

### **Fiscal Impact:**

Additional capital expenditure in the South Traffic Impact Fund in the amount of \$1,874,092. Potential budget impact in 2025 and if project is not completed this year, then 2026. Funding for this project will be from unrestricted fund balance in the South Traffic Impact Fund.

The South Traffic Impact Fund generates revenue from traffic impact fees from new developments. These funds are reserved until projects arise. This Quincy construction project is an allowable project for the South Traffic Impact Fund.

### **Staff Recommendation:**

RESOLVED, that the 2025 Budget adopted by the Board of County Commissioners on November 19, 2024, is hereby amended as follows:

- 1. The budget and appropriation of the General Fund for the Business Innovation and Technology Department are hereby increased in the amount of \$192,000 for a cybersecurity state grant; to be offset by a like amount of state grant revenue.
- 2. The budget and appropriation of the General Fund for the Sheriff's Office are hereby increased in the amount of \$15,000 for the Department of Local Affairs Peace Officer Mental Health Grant; to be offset by a like amount of state grant revenue.
- 3. The budget and appropriation of the General Fund for the Sheriff's Office are hereby increased in the amount of \$118,779 for administrative adjustments for the State Criminal Alien Assistance Program; to be offset by a like amount of federal grant revenue.
- 4. The budget and appropriation of the General Fund for the Sheriff's Office are hereby increased in the amount of \$963,000 for administrative adjustments for a federal grant to assist with Time Division Multiple Access (TDMA) Radio Interoperability Upgrades; to be offset by a like amount of federal grant revenue.

- 5. The budget and appropriation of the American Rescue Plan Fund for the Strategy, Innovation and Finance Department are hereby decreased in the amount of \$861,678 to remove staffing support; and a like amount restored to the unrestricted fund balance in the American Rescue Plan Fund.

The budget and appropriation of the Conservation Trust Fund for the Parks and Conservation Department are hereby increased in the amount of \$25,000 for the Bowles Metro District, Sunset Park Community Partnership Program; to be offset by a like amount of unrestricted fund balance in the Conservation Trust Fund.
- 7. The budget and appropriation of the Fleet Services Fund for the Operations Department are hereby increased in the amount of \$15,000 for the National Renewable Energy Laboratory Technical Assistance program; to be offset by a like amount of federal grant revenue.

- 11. The budget and appropriation of the Patrol Fund for the Sheriff's Office are hereby increased in the amount of \$74,823 for administrative adjustments for the Speed Mitigation Grant; to be offset by a like amount of federal grant revenue.
- 12. The budget and appropriation of the Patrol Fund for the Sheriff's Office are hereby increased in the amount of \$20,000 for the 2025

Click It or Ticket Grant; to be offset by a like amount of federal grant revenue.

- 13. The budget and appropriation of the Rescue Plan Project Fund for the Strategy, Innovation and Finance Department are hereby increased in the amount of \$861,678 for staffing support; to be offset by a like amount of unrestricted fund balance in the Rescue Plan Project Fund.
- 14. The budget and appropriation of the South Traffic Impact Fund for the Development and Transportation Department are hereby increased in the amount of \$1,874,092 for the Quincy Reimbursement Agreement; to be offset by a like amount of unrestricted fund balance in the South Traffic Impact Fund.
