11. Regulation Number 30

The Division will request that the Commission set a hearing to consider establishing a new Regulation Number 30 to identify up to five priority air toxic contaminants, in response to HB 22-1244.

Comments will be accepted during this time on Regulation Number 22 to address changes EPA made to the federal GHG reporting rule and to expand GHG reporting requirements to municipal solid waste landfills that do not currently report GHGs. Spoken comments provided during this time and written comments submitted in advance will be incorporated into the rulemaking record. **The session may end early if all commenters that are registered and in attendance have had an opportunity to speak.**
