**Issue:** Budget supplement for the previously submitted and awarded Clean Energy to Communities (C2C) Technical Assistance program from the National Renewable Energy Laboratory (NREL).

**Background:** The Grants Management Team partnered with Fleet Services staff to apply for the C2C program in October of 2024. The C2C program is a technical assistance program managed by NREL and funded by the U.S. Department of Energy. Staff received notification that the application was successful and that, in addition to technical assistance from NREL, Drive Clean Colorado would provide additional support. The objective of this assistance is to develop recommendations for a five and ten-year strategic planning to integrate alternative fuel and electric vehicles into Jefferson County's Fleet.

The C2C program has collaborated with Fleet staff since December 2024 and will conclude in Spring 2025 with final reports from NREL and Drive Clean Colorado. These consulting efforts support Fleet's goal of developing effective, achievable goals aligned with the Jefferson County Climate Action Plan.

**Discussion:** To date, NREL has created an in-depth analysis of fleet data, including vehicle location, fuel, routes, and vehicle types. The five and tenyear plan recommendations from Drive Clean Colorado are expected later this spring. The recommendations are expected to set fiscally responsible and achievable goals for increasing the number of alternative fuel and electric vehicles in the fleet, along with expanding fleet-specific vehicle charging stations locations.

These in-kind consulting services are valued at \$20,000, starting with \$5,000 in services in December 2024, with the remaining \$15,000 applied in 2025.
