**Issue:** The Jefferson County Sheriff's Office (JCSO) requires approval and ratification from the Board of County Commissioners (BCC) to submit a grant application to the Rocky Mountain High Intensity Drug Traffic Areas (HIDTA) on behalf of the West Metro Drug Task Force (WMDTF) and accept funding for the 2025 fiscal year, 1/1/2025 – 12/31/2026 up to an amount of \$282,000.

**Background:** The JCSO has been part of the WMDTF since 1997 and now manages all financial responsibilities for the WMDTF. Managing HIDTA funds for WMDTF will include receiving and paying invoices from the Golden Police Department, Lakewood Police Department, and Wheat Ridge Police Department for overtime costs associated with drug investigations. The JCSO also employs investigators that will be working overtime and charging their hours to the HIDTA grant. The HIDTA funds are essential for the operation of the WMDTF. The funds requested support overtime, administrative costs, service contracts, investigative/operational expenses, and office supplies.

**Discussion:** The JCSO is requesting grant funding to continue with the HIDTA program. The funding will cover overtime costs of current employees of the JCSO, Golden PD, Lakewood PD, and Wheat Ridge PD. The funding will also cover supplies, wireless service, equipment maintenance, and trial expenses associated to witness protection.
